We are excited for the start of the 2019 Taylor Farmers Market and eager to implement some exciting new changes!

Our goal is to continue to build the market for the betterment of our local farmers, artisans and small business owners. In by doing so, we hope to provide our downriver families with a unique shopping experience.

Our market hours will be from 11:00 am – 6:00 pm, each Friday, beginning June 7, 2019 and ending on August 30, 2019. ***We will NOT have a market on Friday, June 28, 2019, so that we can celebrate the Taylor Summer Festival.*** The market will commence the following week and will continue through the remainder of the season. However, dates and times are always subject to change, ONLY if necessary.

Vendors are provided a space under the Sheridan Open Air Pavilion located in our beautiful Heritage Park.

We offer a discount if you commit to and pay \$120 for the entire season up front. Our weekly rate for space is \$15. In order for us to highlight and promote your business it is imperative that you give us at least a 48-hour notice if you will not be in attendance. Please be advised that we do not offer refunds for vendor fees.

PLEASE NOTE THE FOLLOWING:

The Farmers Market is now being managed through the Taylor Recreation Center located at 22805 Goddard Rd., Taylor, MI 48180. The Recreation Center hours are Monday-Friday 6 am to 9 pm, Saturday 7 am to 5 pm and Sunday 12 pm to 5 pm. We are able to accept cash, check, credit or debit for vendor fees. You have the option of mailing in your vendor application or dropping it off in person.
