I acknowledge that although the City of Taylor has taken measures to minimize the risk of injury to me and my guests, the City of Taylor cannot and does not insure nor guarantee that the participants, equipment, facilities, grounds, and/or activities will be free of hazards, accidents and/or injuries. I agree and recognize that my and my guest's participation in such activities and/or use of such equipment, facilities and grounds may result in injury, illness or death and I agree to assume all risks and dangers and all responsibility for any losses, damages, and injuries arising out of my own or any invited guest's participation in activities in location checked above and/or the use of any equipment, facilities, servicing and/or grounds at the parks.

That on behalf of myself and my guests, I agree to release, waive and discharge any and all liability against the City of Taylor and their agents and employees, and to hold harmless, indemnify and defend the City of Taylor and their agent, officers, officials, employees and volunteers from and against any and all claims, actions, losses, liabilities, injuries, damages, wrongful death, fee, expenses and attorney fees, which may arise out or be related to myself and my groups participation in the above described activities and/or the use of any equipment, facilities and/or grounds in park designated above in the City of Taylor, whether or not caused in whole or in part by the negligence and/or gross negligence of the agents, employees, officers, officials and/or volunteers of the City of Taylor.
